RULES & REGULATIONS

TRAIL AND/OR MOUNTAIN BIKING

Article 1: Activity

La Vallée de Ferney Co Ltd (hereinafter the “Company”) will give access to tracks at Ferney La Vallée (hereinafter “FLV”) for its registered members (hereinafter the “Members”) to enjoy running, walking and/or biking on the tracks (hereinafter the “Activity”)– this Activity is to be supervised and the Members are participating in same at their own risks.

Article 2: Registration

Registration must be done through the website www.ferney.mu. Membership cards will be issued following successful registration and payment. All compulsory information regarding the Activity, including a map of the tracks, is available on the website and/or on a signage board at the entrance of FLV.

Article 3: Procedure

Members may have access to FLV as from 6.30 a.m. to enjoy the activity chosen. Members shall present their membership card to the watchman at the entrance of FLV and sign the logbook to record their entry. After choosing the desired track from the signage board, Members may proceed directly to enjoy their chosen Activity. Before leaving FLV, Members must sign the logbook to record their departure.

Article 4: Membership Card

The membership cards must be available for presentation at all times and on any part of the tracks.

Article 5: Children (below 12 years)

Children below the age of 12 must be accompanied by an adult at all times.

Article 6: Consent Form

The ‘consent form’ must be filled in by the legal guardian (for children below 18 years) authorising the minor to take part in any of the Activity.

Article 7: Prohibition

The following are strictly prohibited at FLV:

- a. Domestic animals.
- b. Unauthorised access to any closed areas, including animal habitat zones.
- c. Unauthorised feeding of the animals.
- d. Cultural site disturbance, including digging, burying, disturbing the soil, breaking of plants/branches/leaves.
- e. Disturbing, destroying, vandalising and/or removing property, including signs and markings.
- f. Littering and the disposal of waste or abandoning of property.
- g. Polluting or contaminating any water source (e.g. with soap, waste etc.).
- h. Hunting of artefacts and the use and/or possession of firearms, air guns, paintball guns and any other types of weapons.

- i. Lighting of fires.
- j. Climbing on observation towers (Miradors).
- k. Shouting and/or being noisy (in consideration of the natural habitat of the species and other visitors and/or members).
- l. Smoking and/or consumption of drugs and/or alcoholic drinks. Note that consumption of alcohol is only allowed in the restaurants and/or on specific events with prior authorisation.

Article 8: Mobile Phones

- a. Careless and hazardous use of mobile phones must be avoided (e.g. taking pictures/recording in dangerous zones).
- b. Mobile phones must be switched to silent mode so as not to disturb the natural surroundings.

Article 9: Food and Refreshment

Food and drinks are not allowed on tracks except for water and light snacks.

Article 10: Pregnant members

Pregnant Members must exercise caution and care at all times and any activities carried out will be at their own risk.

Article 11: Parking

Parking of vehicles at FLV shall be at the risk of the Members and the Company shall not be held liable for any loss or damage.

Article 12: Photo, TV or video coverage and associated rights

Members hereby expressly renounces to any image use/video recording right and to any legal proceedings in this regard against the Company, its employees and/or its agents for any use made of their image/video recording. The Company, its employees and/or its agents may make use of such images/video recording without the prior consent of the concerned Member.

Article 13: Tips

Any tips should be handed directly to the relevant persons.

Article 14: Indecent or Disorderly conduct

Indecent or disorderly conduct may result in the cancellation of the Activity and/or the membership without a refund.

Article 15: Designated Tracks

Running and riding are permitted only on the designated tracks; diversion to other tracks may result in the cancellation of membership.

Article 16: Emergency

In cases of emergency, all costs/charges must be borne by the Members (e.g. transportation etc.).
